Sealed tenders are invited from the reputed and experienced decorators who have experienced in the line and worked in a Central/State Govt. offices, for construction of pavilion in the forthcoming Industrial India Trade Fair to be held during 24th Dec. 2009 to 3rd January 2010 at Milan Mela Complex (opp. Science City EM By Pass).

The quotations should reach this office latest by 25th of Nov. 2009 within 4:00 p.m. The bidder must submit the copies of up-to date trade license, IT clearance certificate & credentials along with the quotations. If the bidder already has some past work experience with MSME-DI (or Formerly SISI), relevant papers may be enclosed. The work as mentioned below as per lay out and specifications should be completed on or before 21st Dec. 2009 within 5:00 p.m. failing which the bidder will be liable to penalize as per Rules.

LAY OUT, SPECIFICATIONS, TERMS & CONDITIONS:

1. Covered area - 200 sq.mtr. (Approx)
2. No. of stalls measuring approx 5'X4' - As per requirement
3. Pavilion should be erected with iron structure, wood & bamboo, outside covered with corrugated sheet, plywood (4mm, 8mm, 12mm, 20mm), cloth flex, acrylic sheet etc.
4. Podium & Shelves would be erected inside the pavilion as per requirements of the authority.
5. Iron collapsible gates - 2 nos.
6. Floor would be covered with jute mat.
7. Display Board would be made of plywood in each stall.
8. Glass to be provided by the decorator as per lay out and design.
9. Facia of each unit would be written by the Decorator.

- 10. Front view of the MSME pavilion would be written by decorator as per lay out and design .**
- 11. Platform would be 1' high inside the pavilion.**
- 12. 100 Nos. of decorative ultramodern decent chairs without arm.**
- 13. Inside & outside wall would be finished by two coats wood prima and two coats acrylic colour (Berger/Asian Paints). After painting, no joint of the plywood and texture of the wood should be viable inside or outside of the pavilion.**
- 14. Decorators would be responsible for any loss or damage of decorating materials during the period of Trade Fair.**
- 15. MSME-DI, Kolkata is entitled to stop payment if the allotted work is not done Satisfactorily.**
- 16. MSME-DI, Kolkata is empowered to cancel the tender any time without assigning any reason.**
- 17. Liquidated damage or theft of any equipment supplied by the contractor at the site or outside, MSME-DI, Kolkata will not be responsible to repair/ replace or to deliver for those tangible items at their office or any legal implications.**
